NOTIFICATION

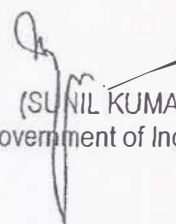
Whereas **"Narsee Monjee Institute of Management Studies (NMIMS)**, Mumbai was declared deemed to be a university under Section 3 of the University Grants Commission (UGC) Act, 1956 vide this Ministry's notification of even number dated the 13th January, 2003 subject to certain conditions that included a review after three years;

2. And whereas, the UGC has reviewed the functioning of the "NMIMS", Mumbai through an Expert Committee constituted for this purpose;

3. And, whereas, on the basis of the report of the Expert Committee, the UGC have recommended continuation of the status of 'Deemed-to-be-University' to "NMIMS", Mumbai, on a permanent basis;

4. Now, therefore, the Central Government, in exercise of the powers conferred by Section 3 of the UGC Act, 1956, and on the advice of the UGC in the matter, do hereby accord approval to the continuance of **"Narsee Monjee Institute of Management Studies (NMIMS)"**, Mumbai, as a deemed-to-be-university for the purpose of the aforesaid Act, strictly in terms of this Ministry's notification of even number dated the 13th January, 2003 subject to the conditions that (i) they will adhere to the norms and guidelines prescribed by the UGC and the All India Council for Technical Education (AICTE), from time to time, as are applicable to the institutions declared as deemed-to-be-universities under Section 3 of the UGC Act, 1956 and that (ii) they shall not make any admission at any of their proposed off-campus centres until formal approval of this Ministry is granted for the operation of these campuses.

5. The declaration made in para 4 above shall be subject to further conditions that are mentioned at Sl. No. 4 of the endorsement of this notification.
