3. Candidates have to submit form (Section 1/2/3) within time limit (9.00 to 10.30am) failing which the form will not be submitted & candidate may not be considered for next process of personal interview
4. Candidates are require to submit Section 3 Part B essay test response in PDF format to email ID [mbalaw.2020@nmims.edu](mailto:mbalaw.2020@nmims.edu) failing which the candidate may not be considered for next process of personal interview

5. Test will start at 9:00 AM. Test Duration: (Section 1/2/3) : 1.5 hr (9.00 to 10.30 am ) & Section 3 part B Essay test: 0.5 hr (10.30 to 11.00 AM)
6. Please remember the time limit is binding and no extension will be provided whatsoever.
7. If the applicants miss the time limit, it will be deemed as no-show, their test responses may not be evaluated and the test may be disqualified.
8. As this is an online examination, set your computer connected 30 minutes prior to start of exam to avoid any probable glitches at the start. It is your responsibility to ensure that you have access to the internet / email .
