### **HEI Response:**

HEI has noted the DVV comments and is providing additional documents and explanation to support its claim as below:

HEI input for the metric is A – "Feedback collected, analysed, action taken and communicated to the relevant bodies and feedback hosted on the institutional website".

1. HEI has attached relevant documents which substantiates the communication of the change of syllabus suggested by various stakeholders and which has been placed in statutory bodies like BoS for recommendations on change of syllabus, Academic council for its approval and Board of Management for ratification/endorsement.

Additionally, HEI wishes to highlight that every department has alumni, students, industry experts and peers as a part of various statutory bodies. They are committed about the status of their suggestions in the Action taken report which is the first point of the next meeting.

There is a robust process at NMIMS of collecting 360 degrees feedback and closing the loop. All the feedback is collected and analysed. Note that not only average or standard deviation but detailed statistical analysis (Median, 1<sup>st</sup> Quartile and 3<sup>rd</sup> Quartile) is carried out for each program feedback at the university.

Thus, HEI has a structured process for:

- a. Collecting feedback on curricular aspects after every semester
- b. Detailed statistical analysis carried out by HEI
- c. Displayed on HEI website (for each faculty on their web page)
- d. Communicated to relevant stakeholders (annually)
